



GARDA TRENTINO HALF MARATHON - RULES 2021

This rules is written in the absence of rules relating to covid 19. If in November 2021 the competent authorities in Italy ask us to comply with particular health regulations, which we are not able to know today, the regulation may be subject to variations.

The race will take place on 14th November 2021 in Riva del Garda with any type of weather conditions

Participation requirements: The event is open to all athletes being at least 18.

Participation limit: 4.000

To participate in the non competitive it will be enough to present an health form. Here you can download the form that has to be filled out and stamped by your doctor.

If you are not an I.A.A.F. athletics cardholder you must provide us with the health form and run the non competitive .

If you prefer to take part in the competitive race, have the chance to compete for the prize and be included in the FIDAL / IAAF ranking list you have to :

- ✓ hold membership of a foreign Sports Federation affiliated with IAAF and in this case you have to provide Garda Trentino Half Marathon with a copy of the association license or a self declaration in which you declare that you are affiliated with a sports club;
- ✓ get the FIDAL Runcard and provide Garda Trentino Half Marathon with a copy of the medical certification which allows you to take part in **competitive races** according to the Italian law.

Start time : 10.15



Athletes who are not licensed for a Federation of Athletics affiliated to the IAAF(International Association of Athletics Federations must send, upon registration (by fax to +39 075.63062390 or email to garda2021@dreamchrono.it the **health form provided by Garda Trentino half Marathon and it must be filled in, stamped and signed by a doctor **according to legislation enforced in your country.****

REGISTRATION PERIOD

Registrations are open from 01 January 2021 and will be closed on 05 November 2021 unless the number of 4.000 participants has already been reached.

INSURANCE and LIABILITY

Participation is at your own risk. Liability of any kind will not be assumed neither by the organizer nor by the City of Riva del Garda . This also applies to accidents, lost items of clothing and/or other belongings. Upon receipt of the race documents participant bindingly acknowledges the clauses of participation and that participant is in adequate physical condition to take part in the race.

BIB NUMBERS PICK UP

Friday November 12 from 04.00 pm to 08.00 pm ,

Saturday , November 13, from 10.00am to 07.00 pm

Sunday , November 14, from 07:00 am. to 09:00 am.

at the Riva del Garda, PALAFIERE – BALTERA Street 20 , , Riva del Garda , which will also host an Expo area on those same days.

STARTING GROUPS :

The assignment to the grid is based on the race time you maintained with your registration. Late entries are assigned automatically to the last section.

The starting groups will be subdivided according to rankings:

1st group RED : Top athletes, and Amateur /Master Athletes up to 1.19.59

2nd group BLU : Amateur/Master athletes from 1.20.00 up to 1:39:59

3rd group YELLOW : Amateur/Master athletes from 1:40:00 up to 1.59.59

4rd group GREEN : Amateur/Master athletes from 2.00,00

5rd group WHITE : Non competitive race + Nordic Walking & Fit Walking



TIME LIMITS

The time limits is 3:00 hours for runners. Beyond these time limits, the organization does not guarantee the total closing of the race course.

Euro 35,00 for registration from 16 August to 10 October

Euro 40,00 for registrations from 11 October until the closing date 05 november

Euro 45,00 Late registration on 06,07 and 08 November

The registration fee is not refundable. Athletes who are unable to take part in the running competition have the opportunity to transfer his/her registration to another person but only before 20 **october 2021**; on substitution of registration, the new registrant must present all the required documentation.

FINISH

The area for finisher medals and food and drink station will be located after the finishing line. The changing rooms, bag deposit and refreshments zone will be set up outside the PALAFIERE PAD A

MEDICAL SERVICE

The organizers, in collaboration with the local medical service, will prepare and



manage an adequate medical assistance service along the running course and at the starting and finishing points.

TIME-KEEPING SERVICE

The measurement of times and the processing of the classifications will be carried out by ICRON/DREAMCHRONO .

RESULTS

The results of the Garda Trentino half Marathon will be available on the Result page www.trentinoeventi.it . It will be also possible to download the official diploma of participation on the website www.trentinoeventi.it

PRIZE-GIVING

In the PALAFIERE , immediately after the finish, prizes will be awarded to the first 5 men and to the first 5 women absolute winners of the Garda Trentino Half Marathon and to the first 3 Masters in a combined male and female category. Winners' ceremony will take place , on the PALAFIERE . The respective times are 13:00 p.m.

POSTPONE YOUR ENTRY

The athlete, who cannot take part in the race anymore, can transfer the registration to the Garda Trentino HALF Marathon 2022 applying and paying an additional charge for secretary's fees (€10,00) within 20th October 2021.

TRANSFER YOUR ENTRY

The athlete, who cannot take part in the race anymore, can transfer the registration to another runner. The transfer can be only made online by paying by credit card by October 20, 2021 and at a cost of € 10,00 for administrative fees.

Once the registration office has made all the checks on the accuracy of the data entered the registration of the athlete who has transferred the bib will be canceled and only the new registration will be valid. An email will alert the athlete who has transferred his registration of the cancellation of the same.

BAGGAGE AND STORAGE

There will be storage facilities by the start area. Due to safety concerns it will only be possible to hand in the participant bags each runner receives when they pick up their start number. Large suitcases and other bags will not be approved for storage. Participants are asked to clearly label their bags with their start number. Please do not put valuables in your participant bags and arrive in good time as we expect some queueing. Please see the event map for the baggage area.

Garda Trentino Half Marathon notes that any clothing or equipment that is not picked up will be given to the Italian Red Cross .

COMPLAINTS

Complaints must be presented according to the regulations of the U.I.S.P.

PERSONAL DATA TREATMENT

According to what disposed by the Art. 13 D.L.vo 30 June 2003, n.196:

a) Personal data collected in the registration module are requested by the module itself to prepare the lists of the participants, rankings, historical archive and to fulfil what requested by Garda Trentino Half Marathon 2021 rules and to receive the informative material by Trentino Eventi S.S.D.a R.L. and its partners.

b) The consequence of avoiding to send personal data, is missing the participation.



c) The rights of the interested individual relatively the treatment of personal data are disposed by Art. 7 D.L.vo n.196/03. Anytime the interested person can consult, modify or cancel for free his/her personal data writing to the responsible of the treatment of personal data .

IMAGE COPYRIGHT

With the registration to the Garda Trentino Half Marathon 2021 the athlete authorizes the Organization Committee, with the media partners, the acquisition of the right to use his/her moving or still images that eventually portray her/him during the marathon on every support, included promotional materials, for the time provided by the regulation, considering also eventual time extensions that could occur.

VARIATIONS

The Organizing Committee reserves the right to modify these regulations at any time due to modifications that may be made to the U.I.S.P.regulations and for reasons that it deems appropriate for improving the organisation of the race. Any modifications to times, services and locations will be communicated to the registered athletes enrolled in the letter of confirmation, and in any case on the www.trentinoeventi.it internet site.

WAIVER OF LIABILITY

"I declare to know and respect the official rules of Garda Trentino Half Marathon 2021 , published on the website www.trentinoeventi.it , and to be at least 18 years old on the day of the marathon; I declare to own a medical certificate of sportive suitability valid on the 08 november 2021 and to present this certificate with the registration module in case I am not a IAAF/FIDAL member or Sport Promotion Authority CONI member. I know that taking part to the Garda Trentino Half Marathon 2020 and/or participating to other sportive events is potentially a risky activity. I also declare to register consciously and I assume all the risks concerning this decision-making: falls, contact with other participants or vehicles, difficult weather conditions, traffic and all the other risks are known and evaluated by me. Being knowledgeable of what before cited, considering that my registration has been accepted, I release and discharge the Garda Trentino Half Marathon 2021 organization committee, TRENTINO EVENTI S.S.D. a R.L. , Local Council of Riva del Garda, Provincial Council of Trentino , Regional Council of Trentino Alto Adige , the



administration of the places where the marathon passes, the sponsors, from future complaining and from any kind of responsibility connected to my participation to the marathon.

Once the registration has been accepted, the same is not repayable. I concede my authorization to all the organization involved in the planning of the marathon, included the ones previously cited, to use my images, photos, videos on the web site www.trentinoeventi.it and anything relative to my participation to the event for any type of licit use without remuneration”.
